

**Beyond 40 Acres and a Mule:
The History and Practice of Reparations in the African Diaspora**

Description

How did enslaved people and their descendants conceptualize reparations? What strategies did they employ to achieve them? How do present day movements for reparations seek to address historic harms? This ABCS course will examine the history of reparations advocacy amongst enslaved Africans and their descendants from the inception of the transAtlantic traffic in enslaved people to the present day.

This action-oriented course will explore the root of reparations - repair - and the historical and current strategies that people are employing, both nationally and globally, to advance racial and reparatory justice for descendants of enslaved Africans in the United States. By situating reparatory justice initiatives in the context of the African diaspora, the course will examine demands, goals, implementation plans, and organizing methods used by the descendants of enslaved Africans for the harms and legacies of slavery and colonization.

Mirroring the model of the Penn and Slavery Project course, this research seminar provides students with instruction in basic historical methods and an opportunity to conduct collaborative primary source research into Philadelphia's historical connections to slavery. After an initial orientation to archival research, students will plunge into conducting research at historical archives relevant to their final projects including the Kislak Center, the University Archives, the Historical Society of Pennsylvania, the American Philosophical Society, the Library Company, and various online sources.

Final Projects

As an ABCS course rooted in community-engaged scholarship and action-driven research, students' final projects will contribute to reparatory justice in Philadelphia by highlighting new research and/or proposing a repair model/reparatory solution for the harms and legacies of slavery and Jim Crow that impact Black Philadelphians.

Students will design a public-facing final project that utilizes historical research, creative arts and multimodal tools, and community engagement. This can include creating new archives, historical markers, ArcGIS mapping, photography, podcast, videography, animation, a website/database, lesson plans, and rubrics for oral interviews, surveys, a pop-up exhibit, an article, a public presentation, or survey rubrics for reparations research of community members, etc. The course is supported by a curriculum support grant from The Sachs Program for Arts Innovations and can fund some project expenses. A guideline for final projects will be provided. Final projects can be done in teams. Students will have the option to submit their final project as a reparations

recommendation and proposal to The Philadelphia Reparations Task Force which will be submitted to the Philadelphia City Council and Mayor.

Community Partners

Our course community partner is [The Philadelphia 1838 Black Metropolis](#). Students can support and further 1838's work for reparatory justice by expanding on their research into the "Amount of Money Free Black people paid for their freedom in 1838", utilizing and researching the 1847 census to unveil the enslavers who demanded and received the manumission money, and the legacy and impact on Black Philadelphians who were coerced into compensated abolition. Relevant archives to consult include the [Historical Society of Pennsylvania](#).

Students may also expand on the "[Mapping West Philadelphia: Landowners in October 1777](#)" project developed by the University of Pennsylvania's [University Archives and Records Center](#) (UARC) from research provided by UARC archivist J.M. Duffin. Students may select a specific era to track the growth and decline of Black land ownership in Philadelphia. Relevant archives to consult include the [City Archives of Philadelphia](#) and [the Philadelphia Register of Wills](#).

Students may pursue research and scholarship into the City of Philadelphia's "[Slavery Era Business/Corporate Insurance Disclosure and Financial Reparations](#)" ordinance and the obligated financial depositories subject to the law.

Other Options

Students may conduct a final research project that falls outside of the community partners but must identify primary sources to support their research and examine a contemporary issue advocated by reparacionists such as: (1) An aspect of the city of Philadelphia's history of racial discrimination (ie. redlining, the MOVE bombing, etc.); (2) Any issue that falls under the five injury areas of slavery (defined by N'COBRA as Peoplehood/Nationhood, Education, Health, Criminal Punishment, Wealth/Poverty) committed by a financial, academic, religious, medical, or carceral institution within Philadelphia' or (3) a specific case in which African Americans experience disparities due to racial discrimination. For example, if a student chooses to research segregated African American health institutions. They may utilize the Mercy-Douglass Hospital [Records](#) (1896-1977) held at the University of Pennsylvania: Barbara Bates Center for the Study of The History of Nursing.

Course Goals

Students will:

- Explore the catalysts of reparatory demands, historical and contemporary debates for and against descendants of enslaved Africans receiving reparations, and the history and current advocacy and demands for reparations by Africans and their descendants throughout the diaspora.
- Gain skills in archival research, basic historical methods, and collaborative primary source research.
- Produce accurate, original research about an aspect of Philadelphia's historic connections to slavery and/or its legacies.

- Develop skills in critical analysis, conceptualization, narrative construction and formation, identifying and interpreting historical sources, oral communication, utilization of digital humanities tools, and methodologies to engage multiple perspectives.
- Analyze key dilemmas in designing reparations programs (eligibility, feasibility, funding, implementation).
- Define reparations and explain their various forms.

Course Requirements

- At the beginning of the semester, students will complete a pre-questionnaire to assess their knowledge of reparations, the transAtlantic traffic in African humanity, and enslavement. At the end of the semester, students will complete a post-questionnaire to determine the achievement of course objectives.
- This course requires students to be involved in intensive reading.
- Each student will submit 5 one-page reading responses.
- Each student will submit one book report essay on an assigned book by 11:59pm the day before class.
