**Course Description and Level**

This course discusses the political and social implications of sex, race and personal relationships in U.S. political and social history. In this class, we examine how ‘emotional’ experiences such as falling in love, having sex, getting married, coming out of the closet, and other deeply personal events in a person’s life are shaped by political, legal and historical forces. This course will examine the history of marriage rights, claims to ethnic identity, multiracial identity, sex education, and debates about marriage in the 20th century.
